Nel saggio "Cyberstudies and the Politics of Visibility" è interessante come la riflessione dell'autore, anche di taglio riflessivo e autobiografico, metta in collegamento questioni e aspetti anche molto particolari e tecnici dell'uso e del funzionamento della rete (username/user id./pseudonimi, password, protocollo TCP/IP, cookies) con questioni di classica pertinenza degli studi sociali e culturali (identità: costruzione sociale e gestione; comunità e appartenenza; il potere; le subculture).

Phillips stesso nota come il centro del suo interesse sia passato dai temi della sorveglianza e della privacy a quelli della visibilità, dell'identità, della condivisione, dell'affidamento, della comunità).

Tutto ciò si articola diversamente se si considera una dimensione individuale o una sociale delle varie questioni.

Necessità, spesso, di identificarsi, di farsi riconoscere, di accreditarsi (per accedere a siti, a servizi)

ma anche

volontà di farlo in modo mascherato, senza svelarsi

ma anche

interesse a manifestarsi per stabilire relazioni con altri con cui si condividono valori o interessi (farsi riconoscere selettivamente)

Il servizio *Freedom*, della 'Zero Knowledge Systems', disattivato alla fine del 2001, consentiva ai suoi utenti di costituire e gestire identità in rete rigorosamente separate dai loro dati biografici reali (che è comunque necessario fornire per avere diritto all'accesso alla Rete). Il prezzo da pagare era quello di restare prigionieri di un *digital closet*, di uno sgabuzzino (o armadio) digitale, quando invece nella vita reale si era fatto ogni sforzo per liberarsene. La metafora del "negotiating the digital closet" usata da Phillips fa riferimento alla militanza per i diritti civili degli omosessuali, che è uno dei cardini della sua identità *off-line* e che fa del dichiararsi, del manifestarsi uno dei suoi aspetti costitutivi.

Come si gestisce l'identità e il rapporto con il territorio. Le pratiche della subcultura della minoranza gay nella New York dei primi del '900, che mirava a una 'mappatura alternativa' del territorio e alla costituzione di un codice alternativo di segni di riconoscimento tali da consentire ai membri della subcultura di riconoscersi tra loro, facendoli restare però nell'ombra rispetto alla maggioranza non gay. Le pratiche del movimento per i diritti civili degli omosessuali della fine del '900: politicizzazione, rivendicazione, manifestazione, gestione di porzioni di territorio (locali, negozi, quartieri) principalmente frequentati da gay. Due stili alternativi, ma intrecciati e a volte intercambiabili.

Le categorie identitarie sono fluide e costruite, ma soggette a reificazioni e stabilizzazioni in vista dell'accesso a- e del mantenimento di- relazioni politiche, culturali, economiche e burocratiche durevoli.

Le categorie identitarie classificano, (stereo)tipizzano, rendono gli umani oggetti conoscibili, e questa conoscenza è sfruttabile in termini di economia di mercato, di regolazione dei consumi

Un ruolo razionalizzatore in questo senso lo svolgono anche le regolamentazioni legislative sulla privacy, che definiscono quali sono i dati personalmente identificativi, chi può farne uso e come. Ricadute in termini categorizzazione sociale e di politiche economiche e di mercato, oltre che di difesa dei diritti degli individui.

Il *location based shopping*: combinazione di tecnologie geo-referenziali, dati sulla disponibilità di beni merceologici in una data area e profili di 'consumatori' costituiti ricostruendo le loro abitudini e preferenze di spesa. Phillips cita la società GeePS, attiva sperimentalmente nel 2000 tra New York e San Francisco (vedi "Appunti sparsi a favore del Wireless Marketing" <http://mformento.googlepages.com/Appunti.pdf>, non più attiva. Ruolo delle tecnologie dell'informazione nella costruzione dell'identità sociale. Phillips riconosce una somiglianza con il Panopticon, e fa un richiamo al pensiero di Foucault, esemplificando poi con il lavoro svolto nella rete e nei nostri computer personali dai *cookies* ("The Cookie Concept", di Viktor Mayer-Schönberger: http://www.cookiecentral.com/c_concept.htm)





Gianni Bosio <http://www.circologiannibosio.it/stabili/gbosiopage.htm>:

“Gianni Bosio, nato ad Acquanegra sul Chiese (Mantova) nel 1923, è stato il protagonista di un lavoro di ricerca e di organizzazione culturale che ha posto al centro la storia del mondo popolare e delle classi non egemoni, a partire dalle loro stesse espressioni culturali. Storico rigorosissimo fino alla minuziosità filologica sui documenti, è stato anche fra gli anticipatori della storia orale, fra i fondatori del movimento di ricerca e di riproposta della musica popolare, e il teorico più rigoroso del rapporto fra ricerca e organizzazione culturale. Si definiva “organizzatore di cultura,” affermava la necessità di creare una figura di intellettuale “rovesciato” capace non tanto di portare la cultura alle masse, quanto di apprendere da esse e restituire questo sapere in modo da “armare la classe della sua stessa forza” (L’intellettuale rovesciato è il titolo del libro che raccoglie i suoi saggi; altri libri significativi sono il *Giornale di un organizzatore di cultura* e soprattutto l’incompiuto *Il trattore ad Acquanegra sul Chiese*, una ricostruzione totale della relazione fra trasformazioni economiche, tecnologiche e culturali in un territorio specifico).

Dopo aver partecipato giovanissimo alla Resistenza, Bosio aveva aderito all’ala libertaria, luxemburghiana, del Partito Socialista. Nel 1949 fonda la rivista *Movimento operaio*, la prima rivista dedicata alla storia del movimento operaio in Italia. Il fatto che consideri la storia della classe qualcosa di autonomo rispetto alla storia delle sue istituzioni, partiti e sindacati, e dei loro gruppi dirigenti; che attribuisce importanza decisiva alla dimensione locale e ai filoni minoritari; che intenda fondare l’autonomia della storia delle classi non egemoni su una rigorosa acribia filologica – tutti questo lo fa entrare in conflitto con la storiografia ufficiale dei partiti di sinistra, finché nel 1953 viene estromesso dalla rivista. Fonda nello stesso anno le Edizioni Avanti, che pubblica saggi, documenti, materiali teorici e testi letterari sulla storia e l’ideologia del movimento e della classe operaia.

A partire dal 1962, inizia la produzione di dischi di canti politici e sociali. Bosio ha già cominciato le sue prime registrazioni di canti e racconti popolari, ad Acquanegra e nel Sud. Nascono presso le Edizioni i Dischi del Sole, l’etichetta discografica che fino agli anni ’70 raccoglie praticamente tutta la produzione significativa di canzone politica e canzone popolare in Italia, e il *Nuovo Canzoniere Italiano*, un gruppo di musicisti legati a questo progetto politico-culturale.

Nel 1964 il NCI presenta al Festival dei Due Mondi a Spoleto lo spettacolo “Bella Ciao”, che viene sospeso e incriminato per i suoi contenuti classisti e antimilitaristi. Nello stesso anno, anche a seguito della scissione avvenuta nel partito socialista, le Edizioni Avanti diventano autonome e prendono il nome di Edizioni del Gallo. Nel 1965, insieme con Roberto Leydi e Alberto Cirese, Bosio fonda l’Istituto Ernesto de Martino “per la conoscenza critica e la presenza alternativa del mondo popolare e proletario”. L’iedm diventa luogo di riflessione ed elaborazione culturale a cui fanno riferimento gruppi in tutta Italia – tra cui la Lega di Cultura di Piadena e, più tardi, il Circolo Gianni Bosio di Roma. Soprattutto, l’Istituto intraprende la formazione di un archivio orale che è tuttora il più importante in Italia e uno dei maggiori in Europa.

In tutta la stagione degli anni ’60 e ’70, il movimento i cui Bosio è il principale animatore resta nell’ambito di una sinistra rivoluzionaria e libertaria, ma anche rigorosamente autonomo da ogni appartenenza di partito o di gruppo. Per questo, è uno dei pochi ambienti in cui tutti i filoni della sinistra vecchia e nuova possano convivere in tempi di settarismi e divisioni; ma per la stessa ragione paga la sua autonomia e il suo pluralismo con l’isolamento e la scarsità di risorse che lo porteranno vicino all’estinzione soprattutto negli anni ’70. Oggi, l’Istituto Ernesto de Martino ha ripreso a funzionare e ha sede a Sesto Fiorentino, presso Firenze.

Gianni Bosio muore improvvisamente nel 1971. L’anno dopo, il gruppo di ricercatori, musicisti, attivisti romani che si veniva formando attorno all’Istituto decide di ricordarlo prendendo il nome di Circolo Gianni Bosio.”


